#### 8. PRIZES

Prizes will be awarded for the first 3 boats

#### 9 RISK STATEMENT

- 9.1 Rule 4 of the Racing Rules of Sailing states:
  - "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone"
- 9.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
  - they are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
  - (b) they are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
  - (c) they accept responsibility for any injury, damage or loss to the extent caused by their own actions and omissions:
  - (d) their boat is in good order, equipped to sail in the event and they are fit to participate;
  - (e) provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.
- 9.3 The fact that the race committee conducts inspections of a boat does not reduce the responsibilities of each competitor set out in these Sailing Instructions.

#### 10. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3 million (three million pounds) per event or the equivalent. Competitors shall sign a declaration to that effect at registration. Insurance is the sole responsibility of the competitors.
